StockMins – Lamb Grower

A dry, molassed, weather resistant premix for feeding to lambs at pasture or in feedlots to boost protein, mineral, vitamin and trace element levels in the diet and to promote growth. Bovatec® is included to improve liveweight gain and feed conversion efficiency.

Active Ingredient: Lasalocid sodium (as BOVATEC 20CC) 1000mg/kg.

Also Contains:

Calcium (13.5%), Sodium (15%), Sulphur (1.4%), Urea (7%), trace elements, vitamins and anionic salts.

Directions for Use

Restraints:

USE ONLY to supplement sheep.

Contraindications:

This product should not be fed to dogs, horses or other equids as this may be fatal.

NOT TO BE USED as a single dose treatment.

DO NOT USE in lactating ewes which are producing or may in the future produce milk that may be used or processed for human consumption.

DO NOT feed more than 400mg/head/day of lasalocid sodium to lactating dairy cattle.

DO NOT feed with other ionophores e.g. monensin capsules, liquid or premix.

Reduced daily gain may result at 5 times and mortality from 15 times maximum recommended dose of lasalocid sodium.

Caution: This product contains selenium.

Excessive tissue levels of selenium are toxic. Care should be taken to avoid over-supplementation from this product and/or concurrent use of other products containing selenium. If blood selenium levels are high this product should not be used.

Additional Product Warning:

Do not feed this product to hungry and/or dehydrated livestock.

Access to clean, fresh water must be available at all times when product is in use.

Salt deficient livestock may overconsume. Talk to ANP before use.

Rates of administration:

Mix thoroughly together with other feed ingredients at a rate of 25kg (1 bag) per tonne of mixed feed.

Alternatively, offer free access in troughs allowing a consumption rate of 20g to 50g/hd/day in line with 2.5% of the total diet.

WITHHOLDING PERIODS: CATTLE: MEAT: Zero (0) days MILK: Zero (0) days

TRADE ADVICE: EXPORT SLAUGHTER INTERVAL (ESI): An ESI has not been established for this product.
